Dear Senator Kaine, Senator Cassidy, Senator Warner, and Senator Moran:

The undersigned childhood cancer organizations are members of the Coalition Against Childhood Cancer (CAC2), consisting of childhood cancer organizations and individual advocates, representing millions of Americans who care deeply about childhood cancer. We are writing to urge the Senate to adopt the House passed language of House Bill 623 and pass the Gabriella Miller Kids First Act 2.0. Thank you for your leadership in the fight against childhood cancer.

Childhood Cancer is the #1 disease related killer of kids and teenagers in the U.S. One in five children diagnosed with cancer will die within five years of diagnosis, and, on average their age at death is eight--a full 70 years of expected life lost. One in 285 American children will be diagnosed with cancer before the age of 20. That means that in 2022, 10,470 children (birth to 14 years) and 5,480 adolescents (aged 15-19 years) will receive cancer diagnoses. More than 95% of childhood cancer survivors will have significant health-related issues by the time they are 45 years of age. These health-related issues are side-effects of their cancer or, more commonly, the result of their treatment regimen.

Expanded research in the pediatric cancer space is essential for the complex medical needs of children and adolescents fighting cancer and their families. Your willingness to act provides us with hope for the future. The Gabriella Miller Kids First Act 2.0 will build upon the initial successes of the original Gabriella Miller Kids First Act, enacted in 2014. This law has invested \$75 million in childhood cancer research and is expected to fund another \$50 million before it sunsets in 2023. The reauthorized legislation will continue and expand the Kids First Program to develop a more robust comprehensive shared-data resource for scientists researching hundreds of different pediatric cancers and structural birth defects.
